### DESCRIPTION:

ArmaFloor™ 500 DF is a two- component, rapid curing, hybrid polyurea coating system designed as a Decorative Finish yet durable coating for floors and other applications. Formulated with aliphatic chemistry, ArmaFloor™ 500 DF is colour stable allowing it take UV exposure without colour shifts seen with other coating systems such as epoxies. ArmaFloor™ 500 DF is a 1:1 mix ratio system with sufficient pot life to be rolled, or sprayed with Rhino Linings® application equipment.

## **SURFACE PREP OF ArmaFloor™ 500 DF:**

See Rhino Linings® Application Standards for full surface prep instructions. Substrate should be clean, dry and free of oils and other contaminants. Rhino™ recommends diamond grinding or shot-blasting for creating surface profile. **Acid or wet etching is not recommended.**

## **THICKNESS:**

ArmaFloor™ 500 DF is typically applied in two coats, a pigmented Base coat and clear Final coat. Decorative Flakes (paint chips) or coloured quartz aggregate are broadcast into the Base coat. Total coating thickness is typically 0.38 to 0.51 mm (15 to 20 mils) with Decorative Flakes. See Rhino representative for your specific application.

## **STORAGE & SHELF LIFE:**

ArmaFloor™ 500 DF components should be stored in sealed containers at 16°C -32°C in a dry area.  
Part A - Isocyanate: Six months, unopened, stored properly  
Part B - Resin: Twelve months, unopened, stored properly

## **COLOUR OPTIONS:**

Colour - Clear

Standard colours available: grey, beige and terra cotta.

Custom colours are also available by special order.

Decorative Flake (paint chips): up to 6 Std colours; Decorative Quartz: up to 6 Std colours
